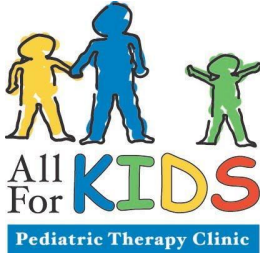
All For Kids continues to maintain and implement precautions and policies to operate safely and prevent the spread of COVID-19. We are continuing to implement the following precautionary measures to keep our clients safe:

- Waiting room closure. Please adhere to the following steps when coming to therapy:
 - Wait in your car and call the front desk at 907-345-0050 to check in.
 - Your therapist will walk to your car to pick up and drop off your child.
 - Parents/caregivers must be in the parking lot at least 5-10 minutes before the therapy session ends.
 - Please report any concerns/updates to your therapists from your car before they escort your child into the building.
- Assigning therapy staff to individual rooms and limiting the number of people in shared spaces,
- Staff wearing masks when treating clients,
- Parents and caregivers wearing masks when in the clinic,
- Clients are encouraged to wear a mask or face shield as able,
- Washing staff and client hands with soap and water or alcohol-based sanitizer at the start of every session,
- Sanitizing toys and surfaces following sessions (including use of an electrostatic sanitizing sprayer), and
- Offering teletherapy services when appropriate for at-risk clients and families who wish to remain at home.

Please contact the front desk immediately to inform us of any COVID-19 symptoms, positive COVID-19 test, COVID-19 exposure, or recent travel or travel plans.

All For Kids' COVID-19 policy for positive cases is as follows:

- Clients who are symptomatic must quarantine from the clinic for 10 days after onset of symptoms (day 0). They may return on day 11 given that they are fever free without medication for 24 hours and symptoms are improving.
- Clients who are asymptomatic with a positive test must quarantine from the clinic for 10 days after the positive test date (day 0). They may return on day 11, unless they develop symptoms. If the client develops symptoms, the day of symptom onset will become the new day 0.

All For Kids' COVID-19 exposure policy is as follows:

- Unvaccinated clients exposed to a contact who tests positive for COVID-19 must quarantine from the clinic for 10 days from the last day of exposure (day 0). They may return on day 11.
- Fully vaccinated clients may continue to come to appointments but are required to get tested 3-5 days after exposure.

All For Kids' travel policy is as follows:

- Unvaccinated clients who have traveled outside of Alaska for >72 hours may return to the clinic after 5 days following return with a negative COVID-19 test.
- If an unvaccinated client is unable to obtain a COVID-19 test, they may return to the clinic after 10 days.
- Fully vaccinated clients may return to the clinic immediately following travel without a COVID-19 test.

Do not send your child to therapy if they are feeling sick. If your child has COVID-like symptoms or a fever, keep them home until he or she is fever-free for 72 hours without medication and symptoms have resolved. If your child presents with symptoms in therapy, staff are required to send your child home. Similarly, staff are always instructed not to work if they are feeling sick.
